



### *Butterfly Wings Coloring Contest: Official Rules*

Woodland Park Zoo, the Sponsor, will conduct the Contest substantially as described in these rules, and by participating, each participant agrees as follows:

#### I. Description of Contest/Participation.

A. Dates of Contest: The Contest will begin on Saturday, May 1, 2016 at 5:30 p.m. and end Friday, July 15, 2016 at 11:59 p.m. PST.

B. How to Enter: As of time of entry, entrant must: 1.) Tear out (from *MyZoo* Summer, 2016) or print out (from [zoo.org/magazine](http://zoo.org/magazine)) the coloring template, color and complete all questions on the back of the form, and mail their template to Woodland Park Zoo c/o *MyZoo* magazine 5500 Phinney Ave N. Seattle WA 98103 OR drop off entry at any membership office, entrance gate or Zoo Store at the zoo; 2.) Include participant's name, age, guardian's name (if applicable), phone number and e-mail in submission and clearly mark which age bracket the participant falls under and if participant will be picking artwork up after the contest; 3.) All participants must be 2 years or older. 4.) Parents may assist children. 5.) By sending us your completed template and entering the contest, entrant represents that they have all necessary rights to grant a license to Woodland Park Zoo to publish and reuse the work for any purpose without compensation and that entrant hereby grants such license together with the right to use entrant's name. All entries must be received or postmarked by **July 15, 2016, 11:59 p.m. PST.**

C. Winner Selection: Six prizes will be awarded at the close of the contest, winners will be selected by Sponsor's staff from among all eligible entries. Three smaller prizes will be awarded for **runners up**. One **GRAND PRIZE** winner will be selected by Sponsor's staff on July 20, 2016 from all eligible entries (ages 7-12) and will receive a voucher for the Overnight Adventure experience at the zoo for the winner and 1 accompanying adult on August 6, 2016 AND a gift certificate for \$50 at Molbak's garden and home. Winners will be notified via the e-mail/phone number provided on their entry and need not be present to win. One **GRAND PRIZE** winner will be selected by Sponsor's staff on July 20, 2016 from all eligible entries (ages 2-6) and will receive a ZooParent adoption and plush AND a gift certificate for \$50 at Molbak's garden and home. Winners will be notified via the e-mail/phone number provided on their entry and need not be present to win. One **GRAND PRIZE** winner will be selected by Sponsor's staff on July 20, 2016 from all eligible entries (ages 13+) and will receive a Tour of the Butterfly Garden with butterfly expert Erin Sullivan (must prearrange tour on a mutually agreeable time and date) and a private afternoon tea with cookies for up to six people (arranged by zoo events staff on the same day) AND a gift certificate for \$50 at Molbak's garden and home. Winners will be notified via the e-mail/phone number provided on their entry and need not be present to win.

D. Disclaimer: The Sponsor reserves the right to amend these rules at any time without notice. The decisions of the Sponsor on all issues regarding this contest are final. Participation is void where prohibited by law.

2. Prize(s). The prize(s) that may be awarded to the eligible winner(s) are: Two winners (runners up) will receive a Woodland Park Zoo t-shirt AND a gift certificate of \$25 to Molbak's garden and home. One adult (runners up) will receive a basket of Zoo Store summer merchandise AND a gift certificate of \$25 to Molbak's garden and home. One winner will take home the GRAND PRIZE ages 7-12: (1) Overnight Adventure experience for 1 child, 1 adult to be used on August 6, 2016 (Value: \$112.00) AND a gift certificate for \$50 at Molbak's garden and home. One winner will take home the GRAND PRIZE ages 2-6: (1) ZooParent adoption and plush (Value: \$69.00) AND a gift certificate for \$50 at Molbak's garden and home. Winners will be chosen on July 20, 2016. One winner will take home the GRAND PRIZE ages 13+: (1) Tour of the Butterfly Garden with butterfly expert Erin Sullivan (must prearrange tour on a mutually agreeable time and date) and a private afternoon tea with cookies for up to six people (arranged by zoo events staff on the same day). If a winner cannot be contacted or is disqualified, Woodland Park Zoo reserves the right to determine an alternate winner or not to award that winner's prize, in their sole discretion.

3. Eligibility and Limitations. Participants and winner(s) must be United States residents, 2-10 years old. Each template counts as one (1) entry per person and multiple entries may be submitted. Employees of Woodland Park Zoo, sponsors, their advertising agencies, and members of the immediate family of any such persons are not eligible to win.

4. Contest Rules and Decisions. By participating in contest, each participant agrees to be bound by the official contest rules and the decisions of Woodland Park Zoo. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means may be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Sponsors will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Sponsors' decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Sponsors, the Sponsors reserve the right to terminate this Contest, or make such other decisions regarding the outcome as the Sponsors deem appropriate. The Sponsors may waive any of these rules in its sole discretion.

By participating, where allowed by law, all participants and winner(s) grant the Sponsors exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use. By participating in the Contest, where allowed by law, participants agree that the Sponsors may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.

If the entry for the Contest requires creative material from the participant/entrant, by submitting your entry: (1) you agree that your disclosure is gratuitous, unsolicited and without restriction and will not place the contest sponsors under any fiduciary or other obligation, that the Sponsors are free to disclose the ideas on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to you; (2) you acknowledge that, by acceptance of your submission, the contest sponsors do not waive any rights to use similar or related ideas previously known to sponsor, or developed by their employees, or obtained from sources other than you; (3) you are verifying that you are the owner and producer of the submitted material and that no third party ownership rights exist to any material submitted, and (4) you are hereby granting the Sponsors a perpetual, worldwide, non-exclusive, royalty-free, sub-licensable (through multiple tiers) right and

license to use, publish, reproduce, display, perform, adapt, modify, distribute, have distributed and promote such content in any form, in all media now known or hereinafter created, anywhere in the world, for any purpose.

By participating in the Contest, each participant and winner waives any and all claims of liability against the Sponsors, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize.
